As a **Transport Coordinator** working on the **GSC - Global Distribution & Logistics Team**, you will be taking care of inbound transportation project completion including implementation of carrier changes in the network. You will be responsible for Central Eastern Europe Distribution Optimization & German RDC implementation and 3PL partner management. You will also secure transportation optimization in inbound flows and will be managing business performance with plants and carriers.

Key Responsibilities

- Support deployment and maintenance of the Takeda Global Transportation strategic approach
 in collaboration with local and global stakeholders to establish reliable, compliant and cost
 effective concepts and processes for the transportation of medicinal products from plants to
 warehouses and customers focusing on sea freight for overseas markets.
- Act as key point of contact towards key manufacturing units (internal plants and External Supply), key transport service providers, QA GDP Global team, Global Distribution coordination teams and Procurement.
- Organise and manage regular Business Performance reviews on Key Performance Indicators with strategic Transport Service Providers (Global and Regional)
- Manage regular communication and reporting on key transportation metrics on agreed geographic scope
- Support data analytics initiatives and consolidation of all logistics data to bring transparency on the performance, costs, carbon footprint and service level to report and to identify improvement opportunities
- Support QA teams with regard to Deviations management, Corrective and Preventive Actions,
 Change Requests and other QA investigations
- Support the sourcing, selection, contract management and deployment of transport partner together with Procurement, Quality and Legal
- Actively support the implementation of global or regional initiatives on transportation network optimization: sea freight, temperature monitoring solutions, forwarders portfolio optimization, etc.

- Support QA GDP teams and sites to deploy new GLOBAL QA GDP SOP's on transportation, temperature monitoring and risk mitigation plans
- Support sites to maintain transport master data in SAP (dates of collection, planned delivery times, Incoterms, etc.).
- Maintain a global cost to serve database to support plants, business development teams and other GMS function to evaluate end to end products costs
- Assess the network capacity utilisation
- Report status on projects on a monthly basis
- Validate and approve transport invoices of selected network carriers.
- Review carrier invoices against agreed rates and internal guidelines on agreed geographical scope
